## **NEW! APA "ADA Specialist" Program**

The Accessibility Professionals Association Board of Directors is proud to announce the development of an "APA Specialist" designation program which will be awarded to individuals who attend specific APA training and pass a written test. The designation will be limited to members of APA who will be promoted on the APA website, receive a certificate and the right to market this specialized expertise.

The first opportunity to receive this designation will be offered at the APA Annual Conference, January 20-22 in Round Rock, TX. Individuals participating in this track, and who attend the 2016 Annual Conference, may also receive AIA, ICC and the required 8 hour of TDLR Continuing Education Credits.

The following is the criteria for the first designation, APA/ADA Specialist, and a link to the APA 2016 Annual Meeting to register. Below are links to future designation programs as well.

#### APA/ADA Specialist criteria:

- 1. Hold a license/certification as RAS, ICBO, CASP, ICC or equal (inquire if you have an alternate)
- 2. Be a member of APA
- 3. Take the prescribed 8 hours of study.
- 4. Pass a written exam with a minimum 75 percent score and pay a \$149 Fee (Paid with Conference Registration)

Course of Study Required - Eight Hours Total Instruction in four categories:

- 1. ADA History/Overview/ Title I
- 2. ADA Title II
- 3. ADA Title III
- 4. ADA Title IV, V, Misc. Provisions, Ongoing Changes
